Pursuant to and in full compliance with California law, due and adequate notice was
 directed to all Persons and entities who are Class Members advising them of the motion for
 attorney's fees and reimbursement of expenses to Class Counsel and service awards to Plaintiffs
 and of their right to object thereto, and a full and fair opportunity was accorded to all Persons and
 entities who are Class Members to be heard with respect to such matters;

2. Class Counsel is awarded attorneys' fees of _____[\$6,410,250] and
reimbursement of expenses of \$_____[\$100,476.62], together with the interest earned
thereon for the same time period and at the same rate as that earned on the Settlement Fund until
paid. The Court finds that the amount of fees and expenses awarded is appropriate and that the
