Stipulation and [Proposed] Order Continuing Hearing Date, Extending Class Deadlines and
Providing Supplement Notice.

1 **STIPULATION**

2 WHEREAS, the Court previously granted preliminary approval of the Settlement, authorized
3 notice to class members, and set a Settlement Fairness Hearing to consider final approval on March
4 18, 2022; and

5 WHEREAS, due to a broker's unexpected delay in providing mailing information to the
6 Claims Administrator, certain Class Members did not receive the Class Notice until recently and
7 thus were unable to submit claims, object to the Settlement, or exclude themselves from the
8 Settlement before the Court-imposed deadlines; and

9 WHEREAS, the Parties agree that impacted Class Members should have additional time to
10 review the Settlement and submit claims, objections, or requests for exclusion; and

11 WHEREAS, the Parties further agree, subject to Court approval, to (1) continue the March
12 18, 2022 hearing date to June ¹⁰ ~~8~~, 2022, ^{at 2pm}, or such other date convenient to the Court; (2) extend the
13 deadline for impacted Class Members to submit claims, object to the Settlement, or exclude
14 themselves from the Settlement Class to May 27, 2022, and (3) provide a supplemental notice to
15 impacted Class Members of the new deadlines and hearing date;


16 NOW, THEREFORE, the Parties, through their respective counsel, agree and stipulate,
17 subject to the Court's approval, that:

- 18 (a) The Settlement Fairness Hearing be rescheduled from March 18, 2022 to June ¹⁰ ~~8~~, 2022, ^{at 2pm}
19 or such other date convenient to the Court;
- 20 (b) The deadlines for impacted Class Members to submit claims, object to the Settlement, or
21 exclude themselves from the Settlement Class be reset to May 27, 2022; and
- 22 (c) The Supplemental Notice, attached hereto, be approved, and the Claims Administrator
23 authorized to mail it to all impacted Class Members, informing them of the extended
24 deadlines and rescheduled Settlement Fairness Hearing, and to update the Settlement
25 website.


